What is GHS?

Brief Introduction

- Why is it important to have a clear understanding of GHS for authoring SDS that is compliant with law.
- Different countries adopted different version of GHS.
- Even with the same version, each country adopts different classifications.
- Different classifications will in turn affect the labelling of substances (for storage and transport).
- Penalty that company could face for non-compliant SDS and labels, business loss.
- Benefits of compliant SDS: improved safety in the workplace, potential for business opportunities because of better alignment between countries, partnership and trade.
- Comparison of GHS implementation of Europe vs Southeast Asia.
 - Version of GHS used in Europe vs SG MY ID.
 - Building blocks adapted by EU vs SG MY ID.

Comparison of SDS Authoring in EU vs Southeast Asia

- EU extended SDS format according to REACH Annex II and including of Exposure Scenario's.
- Content of Section 15 (local inventory and regulation).
- List of relevant regulations for SG MY ID Section 15.
- Language requirements.

Labelling Requirements for Singapore, Malaysia, Indonesia

- Information that needs to be present on the label.
- Label size for different capacity of containers.
- Language requirements on the label.
- Minimum font size and hazard pictogram size.
